Producer's description

The System Sensor, Model M201EA, Single Output Module allows the control of auxiliary devices such as fire shutters or sounders.

This equipment has a single tri-colour LED that indicates the status of the module. In normal conditions, the LED can be set by command from the control panel to blink green when the module is polled. When the control panel switches the relay to the energised state the LED can be set to continuous green.
